#### GENERAL STATEMENT OF POLICY

It is the policy of Westbrook Hay School to protect all persons including employees, pupils, contractors and members of the public from potential injury and damage to their health which might arise from work activities.

The School will provide and maintain safe working conditions, equipment and systems of work for all employees and pupils and provide such information, training and supervision as they need for this purpose.

The School will give a high level of commitment to health and safety and will comply with all statutory requirements.

#### MANAGEMENT SYSTEM

#### Planning

The fire risk assessment is part of the overall Health and Safety documentation for the school. Its purpose is to ensure the well-being of all those working in and around the school.

#### Organisation

The setting is an Independent Preparatory School, governed by a Board of Governors. The Headmaster is responsible for the day to day running of the school and acts as the CEO for Westbrook Hay Educational Trust Ltd, which is the charitable vehicle under which the school operates.



The Bursar reporting to the Governors is currently the person responsible for the Health and Safety of the school. They are assisted by a Health & Safety Officer. The Bursar, Health & Safety Officer, and representatives from across the school comprise the Health and Safety Committee.

#### Monitoring

The Board of Governors are updated on H&S as part of the F&GP Committee. Worknest, a firm of H & S consultants has been retained to act for the school and advise on all aspects of the H & S policy. The school is inspected by the Independent Schools Inspectorate, which monitors all schools within the Independent Preparatory Schools Association, of which Westbrook Hay is a member.

#### Review

As part of the monitoring procedure, periodic reviews of the H&S policy are carried out. In terms of the Fire Risk Assessment, an annual review is undertaken, or more frequently if there are known changes.

#### GENERAL DESCRIPTION OF PREMISES

The site comprises of several buildings contained within a 26-acre rural site, which concentrate in the main around Westbrook Hay House, known as the Mansion. There is a purpose-built Gadebridge Building, a Pre-Prep building, a Performing Arts Centre, a Sports Hall, Science block and a Library/IT block.

#### FIRE WARNING SYSTEMS WITHIN THE PREMISES

There are break-glass systems with automatic fire detection system, to British Standard 5839 linked to electronic sounders in the Mansion, Pre-Prep, Gadebridge building, PAC and the IT block.

In the other areas of the school in isolated buildings, there is clear visibility and word of mouth is deemed sufficient to raise an alarm.

#### **EMERGENCY LIGHTING**

In the above buildings there are emergency lighting systems to British Standard 5266.
